Welcome to the 2019/2020 School Year

On behalf of all at ACCS, I would like to take this opportunity to wish all members of our school communities every success and good health for the school year ahead. The new school year with its changes represents a time for a new start and a fresh approach as school communities come back together renewed after summer holidays and time spent with families and friends. As with every new year, we think about new resolutions and goals for the coming year, reflecting on what we will do differently and are reminded of the words of Jim Rohn:

"Goals.

There's no telling what you can do when you get inspired by them. There's no telling what you can do when you believe in them. And there's no telling what will happen when you act upon them."

The ACCS has set out its goals in its Strategic Plan (2017-2020) and these guide our work for the forthcoming year. This is the final year of the strategic plan which will be up for review in the 2nd quarter of 2020.

In the plan the first strategy places a clear focus on supporting schools in embedding the significant change and new developments evident in the education system currently. We do so "to ensure that students remain engaged in an innovative and progressive educational environment where they can flourish." (ACCS Strategic Plan)

The ACCS goals, in this regard, include supporting schools in establishing effective middle leadership systems where the emphasis is fixed firmly on the core business of teaching and learning. Twentyfive schools are working on developing effective middle leadership systems and a further twenty-five schools are booked to commence work in this area as the second cohort joins the project in November.

Throughout the year, the ACCS Executive ICT Sub-committee will continue its work in developing and sharing materials with schools to assist in planning for, and in embedding the Digital Learning Framework. As with best practice in any planning in school it is important to adopt a robust approach and schools are advised to use the six-stage process of SSE to inform the work. Establishing where a school is and setting out where it wants to be within a certain timeframe and within the framework of Looking at Our School, LAOS, is central to success.

In 2019/2020 ACCS will continue to work closely with the NCCA on its student voice project. There is no doubt that the benefits of capturing and harnessing student voice are well documented in both Irish and international literature. These include enhancing school development and improvement, greater democracy for students, improved teacher-student and student-student relationships as well as enhancing young people's skills and empowering their self-esteem. One of the most important benefits is that we, as adults, can gain access to the specialist knowledge that the learners have about their schools and, in this way, can work with the young people to develop effective learning cultures in which they are active participants who are meaningfully engaged.

Gerry Czerniawski and Warren Kidd (2011) in their book, 'The Student Voice Handbook: Bridging the Academic/Practitioner Divide' describe how teachers/schools can use the student voice to help hear the roar that Mann (2006) described – paraphrasing George Eliot, Middlemarch, (1874):

"getting close to the roar that lies on the other side of the silence of the classroom for it is only in that roar that we can begin to develop an understanding of the lived experience of individuals within classroom, contexts."

In the book they also remind us that we need to compensate for the reticent by giving them more time and listening harder and that when embedding processes in our schools to support 'authentic student/learner voice' we recognise that there are many voices in our schools and in our classrooms.

The quote from Jim Rohn reminds us of the fitting keynote speech delivered by Sr. Marie Céline Clegg at the Seminar for of Community Patrons and Comprehensive Schools in the Mullingar Park Hotel on 26th February 2019. This seminar formally established the new Association of Joint Patrons of Community and Comprehensive Schools (AJPCCS, shortened to AJP). The new association replaces the National Trustee Forum (NTF) which was set up in 2003 and which proved to be an effective organisation for over a decade creating an opportunity for those involved in joint patronage to have a forum whereby joint patrons could engage purposefully with each other and with other relevant Bodies in relation to issues. The NTF also provided patrons the opportunity to have their interests robustly represented at meetings with the Department of Education and Skills.

The new AJP has come about as a result of a highly collaborative effort involving representatives of patrons and ATCS. The Constitution for the new Association has been formulated and accepted by the leadership of all the relevant Bodies and the first AGM is scheduled for later this year.

On wishing the new Executive of the AJP every success in its leadership role, Sr. Maire Céline noted the following:

"Awareness, advocacy and action are now required and must be exercised in a robust, collective and collegial manner if the C&C sector is to lay foundations of hope for future generations while actively acknowledging the legitimacy of a plurality of schools within the system."

Also highlighting the relevance of the words of Dr. Diarmuid Martin:

"A pluralist education system in a pluralist Ireland must be one where battles of ideology are overcome and not reinforced. There is need to form new bonds of partnership to ensure a common vision of education, rather than an antagonistic one, in our pluralist nation."

Schools continue to be busy places and again we commence the year with the hope that schools will be given plenty of opportunities and time to continue to embed the changes which range across Curriculum, Child Protection, SEN, GDPR, Admissions and Finance. In presenting the year's CPD to schools at this time of the year, we hope that school boards and school leaders will endeavour to schedule as many CPD events as possible into your own school calendar throughout this year.

We look forward to meeting you at many of the ACCS scheduled CPD events and remain committed to providing high quality in-service to Boards of Management and school leaders in our schools. Our CPD programme is constantly under review and is informed by input from relevant organisations such as the State Claims Agency, The School Procurement Unit and the FSSU and from our member schools. ACCS also wishes to acknowledge the support and inputs into our CPD programme from a meriad of other educational organisations and Department personnel. The programme commences in late August with a 2-day Induction for New Principals and Deputy Principals and we follow this with Area Information Meetings at the beginning of the school year. All schools are encouraged to book early for the CPD events as in certain instances numbers are strictly capped. The schedule includes events which are offered either on a national basis or where possible on a regional basis.

We take this opportunity to congratulate and acknowledge the service of Principals and Deputy Principals who are retiring this year. It was our great pleasure to meet many of the retirees at the regional meetings across the country in June. Their contribution to their schools and wider communities is greatly appreciated and we wish them every happiness in the next chapter of their lives. To the newly appointed Principals and Deputy Principals, we say welcome and we wish you every success in your new leadership role.

This year the newsletter will retain regular features such as 'Recently Published Circulars' and 'News and Events from Community and Comprehensive Schools'. We encourage you also to visit our website, www.accs.ie regularly where updates and Information Bulletins regarding the implications of relevant circulars are hosted.



Senior Cycle Review

In 2016 the NCCA started a review of senior cycle education, when it completed research on senior cycle/upper secondary education across nine jurisdictions internationally. Following this, teachers, students and parents across 41 schools worked with the NCCA during the school year 2018/2019 to identify key strengths in senior cycle and areas where senior cycle could develop further.

The Interim Report on the Senior Cycle Review brings together the discussions held during the review in schools, at the national seminars and the national and international research on senior cycle. The Senior Cycle Review Consultation document published in July 2019 outlines the emerging areas for further consideration in senior cycle. The senior cycle review is now entering phase three, public consultation.

Having read the reports which can be accessed at www.ncca.ie, the NCCA would like you to consider the areas for further development and have your say. There are several ways to participate in the consultation. See advert opposite.

After this phase is complete, priority areas, longer-term goals and a proposed timeline and advice on the pace and scale for developments in senior cycle will be generated in the form of an advisory report, which will issue to the Minister for Education and Skills for consideration. The NCCA wishes to thank all of those who have contributed to the review to date.



Review of Relationships and Sexuality Education (RSE) in primary and post-primary schools - time to have your say!

In April 2018, the Minister for Education and Skills, Richard Bruton T.D., asked the National Council for Curriculum and Assessment to undertake 'a major review' of Relationships and Sexuality Education (RSE) in schools. The review was conducted between June 2018 and March 2019 and now the NCCA is asking you to read the findings of the review and give your feedback.

Key findings


Overall the review found that there is a high level of agreement that Relationships and Sexuality Education (RSE) is an important part of children's and young people's education today. Equally, there is agreement that schools, in partnership with parents, have a critical role to play in improving provision. The review has highlighted considerable variation in the provision of RSE across schools in terms of what is being taught, how it is taught, who teaches it and the time allocated. Many students described their experience as 'too little, too late and too biological.'

Teachers are aware of the importance of teacher professional development in improving the quality of RSE. They would like to see enhanced training available at both pre-service and in-service levels. In addition, post-primary teachers suggested there should be a qualification to teach SPHE. A further priority for teachers is an up-to-date curriculum which would facilitate learning needed to navigate growing up in the world today. Teachers would like greater clarity on how to approach topics at different stages of children's learning in RSE. However, some pointed out that such guidance should ensure flexibility for schools to respond to their specific student needs. Teachers also felt that more time and smaller classes would facilitate meaningful learning across the range of topics students need to engage within SPHE/RSE. St. Colmcille's Community School A special Celebration for Peace at the Glencree Centre, Co. Wicklow

A celebration of peace took place on Monday 20th May 2019, in the Glencree Centre for Peace & Reconciliation (Glencree) to mark the return visit of HRH The Prince of Wales accompanied by HRH The Duchess of Cornwall. President of Ireland Michael D. Higgins and his wife Sabina welcomed the couple.

The visit was also attended by leaders across civil society. A poem written by the late founding member of Glencree, Una O'Higgins O'Malley and written to honour The Prince's 2002 visit was read to the audience by young people from three schools working with Glencree. After the recital, a specially commissioned engraving of the poem in Wicklow granite was jointly unveiled by His Royal Highness Prince Charles and President of Ireland Michael D. Higgins. The event at Glencree, the first in a series of events on a visit to Ireland by HRH The Prince of Wales and HRH The Duchess of Cornwall, showcased a series of key programmes run by Glencree. The highlighted programmes spanned the areas of Women in Leadership, Legacy and Young Peacebuilders. The event was attended by pupils and teachers from three schools working with Glencree on improving the understanding of young people about British-Irish relations. Students and their teachers from St. Colmcille's Community School (South County Dublin), St. Louis Secondary School for Girls (Dundalk), and New-Bridge Integrated College (Banbridge, NI) shared their reflections and the future relations across these islands.
